Club Volunteer Release and Waiver of Liability Agreement

This Club Volunteer Release and Waiver of Liability Agreement ("**Agreement**") is effective as of _____, 20__ and pertains to membership and Friends of Tahoe Donner Trails Club activities including but not limited to trail building and maintenance, hiking, bicycle riding and horseback riding and other activities connected with the Tahoe Donner trails (collectively, the "**Volunteer Services and Club Activities**") to be performed by the undersigned volunteer ("**Club Member Volunteer**") at the Tahoe Donner Association ("**Association**") Friends of Tahoe Donner Trails Club ("**Club**") events to be held at various dates and times during each year ("**Volunteer Event**"). By signing this Agreement, Club Member Volunteer understands, acknowledges, and agrees to all of the following statements:

1. I will be a club member and serve as a volunteer of the Club, I wish to participate and provide the Volunteer Services to the Club and Association, and I understand that my relationship with the Club and Association is limited to a club membership and volunteer position and that I am not entitled to any wages or other compensation in return for providing the Volunteer Services.
2. I am not entitled to receive unemployment insurance benefits, disability insurance benefits, pension benefits, health insurance benefits, or any other employment-related benefit on account of my volunteer service for the Club and Association, and I understand that the Club and Association is entitled, in its sole discretion, to terminate my services and/or this Agreement at any time, with or without notice, and with or without cause.
3. I understand that the Volunteer Services and the Club Activities may include strenuous physical activity on hazardous terrain which could result in injury, death or other damage, and I hereby certify (i) that I am qualified, in good health, and in proper physical condition to perform the Volunteer Services and to participate in the Club Activities; (ii) that I have no medical conditions or allergies that affect my ability to perform the Volunteer Services or to participate in the Club Activities; and (iii) that I will not be under the influence of alcohol or any illicit or prescription drugs during the Club Activities which would in any way impair my ability to safely perform the Volunteer Services or to participate in the Club Activities.
4. I am responsible for my own insurance coverage in the event that I suffer any personal injury or illness relating, either directly or indirectly, to my participation in the Club Activities, and I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, or illness during the Club Activities.
5. I hereby freely and expressly assume and accept the responsibility for any and all risks of injury while providing the Volunteer Services, while performing any activities related to the Club Activities, or while I am present on the Association's premises during the Club Activities, and I RELEASE, DISCHARGE, AND COVENANT NOT TO SUE the Association, its owners, directors, officers, agents, employees, and any owners of the property upon which the Club Activities takes place (collectively, the "**Releasees**") from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused, in whole or in part, by the negligence or omission of the Releasees or otherwise, including negligent rescue operation; and I further agree that if, despite this Agreement, I, or anyone on my behalf, make a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any litigation expenses, attorneys' fees and costs, losses, liability, damages, or other costs which any of the Releasees may incur as a result of such a claim.
